

Nisco Dg Consult operates Nisco Dg Consult and may operate other websites. It is Nisco Dg Consult policy to respect your privacy regarding any information we may collect while operating our websites.

## Website Visitors

Like most website operators, Nisco Dg Consult collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Nisco Dg Consult purpose in collecting non-personally identifying information is to better understand how Nisco Dg Consult visitors use its website. From time to time, Nisco Dg Consult may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Nisco Dg Consult also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on Nisco Dg Consult blogs/sites. Nisco Dg Consult only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## Gathering of Personally-Identifying Information

Certain visitors to Nisco Dg Consult websites choose to interact with Nisco Dg Consult in ways that require Nisco Dg Consult to gather personally-identifying information. The amount and type of information that Nisco Dg Consult gathers depends on the nature of the interaction. For example, we ask visitors who sign up at Nisco Dg Consult to provide a username and email address. Those who engage in transactions with Nisco Dg Consult are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Nisco Dg Consult collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Nisco Dg Consult. We does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## Aggregated Statistics

Nisco Dg Consult may collect statistics about the behavior of visitors to its websites. Nisco Dg Consult may display this information publicly or provide it to others. However, Nisco Dg Consult does not disclose personally-identifying information other than as described below.

## Protection of Certain Personally-Identifying Information

Nisco Dg Consult discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in

order to process it on Nisco Dg Consult behalf or to provide services available at Nisco Dg Consult websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Nisco Dg Consult websites, you consent to the transfer of such information to them. Nisco Dg Consult will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Nisco Dg Consult discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Nisco Dg Consult believes in good faith that disclosure is reasonably necessary to protect the property or rights of Nisco Dg Consult, third parties or the public at large. If you are a registered user of an Nisco Dg Consult website and have supplied your email address, Nisco Dg Consult may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Nisco Dg Consult and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Nisco Dg Consult takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Nisco Dg Consult uses cookies to help Nisco Dg Consult identify and track visitors, their usage of Nisco Dg Consult website, and their website access preferences.
